The Export-Import Bank of the United States (EXIM) convened meetings of the **EXIM Advisory Committee** (Advisory Committee) and EXIM Sub-Saharan Africa Advisory Committee (SAAC) today at the agency's headquarters. All meetings were open to the public. The Honorable Stevan Pearce, a small business owner and former member of the U.S. House of Representatives and the New Mexico House of Representatives, chairs the Advisory Committee . Daniel Runde, senior vice president and William A. Schreyer Chair in Global Analysis at the Center for Strategic and International Studies, chairs the SAAC

After observing a moment of silence in observance of 9/11, the two committees held their first-ever joint session on priority topics and updates, including on EXIM's programs, reforms, reinsurance pilot program, and Congressional reauthorization process as the agency's charter lapses on September 30. During a working lunch on the topic of "Economic Security is National Security," the focus turned to the United States, China, and the competitive global landscape. Participants were SAAC Chairman Runde; Jim Cruse, EXIM senior vice president for the Office of

Policy Analysis and International Relations; Larry Goodman, Advisory Committee member and president and founder of the Center for Financial Stability; and Jamal Ware, senior advisor on national security. Over the past 10 years, the world's official export credit marketplace has changed dramatically and fundamentally. China has prioritized its use of export credit financing as part of its industrial strategy to create an alternative international finance/trade system. Members of both committees also actively engaged on the importance of supporting small businesses and how the agency is working to fulfill its mission of supporting American jobs by leveling the playing field for U.S. businesses in the competitive global trade environment. The Export-Import Bank of the United States is a tool in the economic and strategic toolbox at a time when global competition has never been more intense," said EXIM Advisory Committee Chair the Honorable Stevan Pearce. "With more than 100 export credit agencies in operation around the world, it is imperative that EXIM be reauthorized to help position American private industry to compete effectively in the

global marketplace. This is not only an economic issue, but a national security issue as well. The world loves 'Made in the USA' products and that's how we compete first and foremost, through the full faith and credit of the United States."

"The Export-Import Bank of the United States' projects have touched all corners of the globe, including Sub-Saharan Africa, which EXIM has a congressional mandate to serve," said EXIM Sub-Saharan Africa Advisory Committee Chair Daniel Runde. "It is critical to reauthorize the agency as EXIM plays a key role in supporting economic growth and development in Africa through the export of 'Made in the USA' good and services. Countries want to do business with the U.S. and

buy from American exporters, which delivers mutual benefits to the United States and our partners in Africa." "Re-establishing these Congressionally-mandated advisory committees, which have not convened since 2015, was a top priority for me,' said EXIM President and Chairman Kimberly A. Reed. "I look forward to working with both committees as to how EXIM can better serve American companies and their workers while also protecting the interests of U.S. taxpayers. President Trump asked me to do great things at EXIM and, as we work hard to transform the agency, today's focus particularly on the topic of China and competitiveness was invaluable.' Stephen Renna, EXIM's chief banking officer, assessed EXIM's programs since the

nation's only export credit agency was restored to full financing capacity earlier this year. The U.S. Senate reestablished a quorum May 8 when it approved Chairman Reed and two additional members of EXIM's board of directors, Spencer Bachus III and Judith D. Pryor. The committee members also received updates from EXIM leaders Lisa Terry, senior vice president and chief ethics officer; David Slade, general counsel; Jim Burrows, senior vice president, Office of Small Business; David Sena, senior vice president, Office of Board Authorized Finance; Ross Branson, senior vice president, Congressional and Intergovernmental Affairs; David Fogel, chief of staff; Lauren Fuller, senior advisor to the chairman; and Mark Klein, regional director.

#### Zeusch Aviation bolsters medevac expertise as King Air B200 operations launch in Spain





Zeusch Aviation, the Netherlands-based aerial services provider, has begun dedicated European medevac operations in Spain using its King Air B200. The Gregistered, G-MEDZ, which has been configured in air ambulance format, is operating regular flights in partnership with IAS Medical, the UK-headquartered private air ambulance company which holds the AOC on which the aircraft operates.

Air ambulance services are being provided for the Spanish aviation organization Eliance which specialises in supporting aerial medical transportation, search and rescue and firefighting. Zeusch has repositioned the modified King Air B200 from its homebase in Lelystad to Malaga, where a crew of two, working on a two-week rotation, is also based to support the mission.

The first medevac operation took-off on 10 July 2019, and since launching the King Air B200 has already transported some 40 patients between Melilla and Malaga, Spain. Patient care is administered by a local professional medical team during the thirty-minute flight.

Melilla is a Spanish enclave located on the north coast of Africa, sharing a border Morocco It has a population of approximately 86,000 and is served by three small hospitals that provide limited healthcare services. The Zeusch flights provide an invaluable service transporting patients to ground

ambulances on mainland Spain, which then transfer patients to clinical centres of excellence.

In its medevac configuration the King Air B200 can carry up to two walking patients or a laying single patient in need of a stretcher. The cabin is equipped with a Lifeport PLUS-system which provides a stretcher, as well as high-tech medical equipment including a vacuum system, compressed air, a three-outlet 1000 watts inverter (230VAC) and a 3500-litre oxygen system with remote filling port.

"Zeusch Aviation is proud to be part of this special operation which is literally life-saving in some cases. These flights not only show the need for specialized equipment and well-trained personnel, but also highlights the capabilities of our King Air B200. Most importantly it also demonstrates the importance of cooperation between entities to fulfil a specific mission," said Zeusch Managing Director, Herman van Kranenburg. "This is enhancing our operational expertise and provides an excellent platform for expanding our medevac operations which we anticipate will widen out across Europe over the next year."

#### ONTARIO HONOURING WORLD WAR I HERO

Durham Region Courthouse Renamed after Lieutenant-Colonel Samuel Sharpe

The Ontario government is honouring a Canadian hero by renaming the Durham Region Courthouse after prominent military leader, lawyer and parliamentarian Lieutenant-Colonel Samuel Sharpe. The courthouse, located on Bond Street East in Oshawa, will now be referred to as the Lieutenant-Colonel Samuel S. Sharpe, DSO, MP Courthouse. "Over the past several years, the province has heard from people at every level of government in the region and members of all political parties - about the importance of honouring Lieutenant-Colonel Sharpe," said Attorney General Doug Downey. "We salute a Canadian hero who bravely fought on the battlefields of Passchendaele and Vimv Ridge while continuing to represent his constituents as a Member of Parliament." Sharpe was born in Zephyr, Ontario in 1873. He was educated at the University of Toronto and Osgoode Hall before being called to the bar and practising law in Uxbridge, including as solicitor for the Town of Uxbridge. He was elected to Parliament in 1908 and served as the MP for Ontario North until his death in 1918. At the outbreak of World War I, Sharpe used his stature and influence to organize the 116th Ontario County Battalion and to ensure it was

Under his command, the 116th Battalion fought valiantly at the battles of Vimy Ridge, Passchendaele and Avion. The heavy combat and the deaths of many of the young men he recruited eventually led Sharpe to relinquish command of his battalion. He was hospitalized for operational stress and died by suicide in Montreal a short time later. He was laid to rest in Uxbridge. The 116th Battalion became the modern Ontario Regiment, maintaining its Ontario County lineage and distinguished record of service to Canada. The armouries of the Ontario Regiment are a short walk from the courthouse that will now bear the name of its first commanding officer and one of Durham Region's legal pioneers.

"This is a humbling opportunity for all of us to reflect on the bravery of our heroes, past and present, and to honour the sacrifices they've made so we can enjoy peace and prosperity," said Attorney General Downey.

#### **ONTARIO RELEASES 2018-19 PUBLIC ACCOUNTS**

Ontario Government delivers on its commitment to transparency and accountability

Ontario's government released the 2018-19 Public Accounts, reinforcing the government's ongoing work to restore sustainability to the province's finances.

Tabled annually, the Public Accounts provide a retrospective look at the government's fiscal performance over the previous year. For the second year in a row Bonnie Lysyk, Ontario's Auditor General, issued a clean audit opinion on the government's books.

"Through prudent fiscal

planning, our government has put Ontario back on a path to balance while restoring transparency and accountability to the province's finances," said Peter Bethlenfalvy, President of the Treasury Board. "Our government's strong fiscal management and smart policies mean we are overcoming the previous government's record of waste and mismanagement. While we've made good progress, there is more work to be done.'

Due to higher than anticipated revenues reflecting strong business profits, a growing job market, higher consumer consumption and lower than expected expenses, the 2018-19 deficit fell from a high of \$15 billion as projected by the Independent Financial Commission of Inquiry to \$7.4 billion.

"Our government inherited a significant fiscal challenge. Today's results demonstrate that our plan to put Ontario's finances back on track and foster a strong economic climate is working," said Rod Phillips, Minister of Finance. "Thanks to higher than anticipated revenue and lower expenses, we have successfully reduced the deficit for the 2018-19 fiscal

year.' By making historic investments in healthcare and education, while modernizing program and service delivery, the government continues to deliver on its commitment to spend taxpayer dollars smarter and focus on what matters most to the people of Ontario. Our plan to restore the fiscal health of the province is working, and we will continue to look for ways to spend smarter and maximize every tax dollar," said Bethlenfalvy. "The release of the 2018-19 Public Accounts of Ontario

demonstrates the hard work that has been done to date to restore the province's finances while directing spending to the services Ontarians rely on every day."

As of October 1, 2019, Ontarians will have easy access to registered nurses and smoking cessation support through Telehealth Ontario, in combination with other services and health information already offered, including professional medical advice, nutrition counselling and referrals to mental health and addictions

support. By transitioning these resources to Telehealth Ontario, the government expects to improve and expand frontline services and supports available to Ontarians, while saving \$750,000 annually. Telehealth Ontario is a free and confidential service for health advice and information 24 hours a day, seven days a week in more than 300 languages. Through the service, registered nurses assess health issues, provide advice and direct callers to the most appropriate care over the telephone. This can also include putting the caller in contact with other health professionals or services.

"We are ensuring Ontarians have simplified access to health care information and advice to make informed choices about their health, and to navigate health care easily," said Elliott. "We appreciate the Canadian Cancer Society for their long-standing partnership in delivering Smokers' Helpline,

and their ongoing work on smoking cessation, tobacco control and other cancer related issues across the country and we are committed to continue working with them to ensure a smooth and seamless transition of telephone-based cessation services to Telehealth Ontario."

The government also continues to fund other smoking cessation services at no cost to the patient, including:

Just one example is support given by Ottawa Tourism in the run up to The Hague hosting One Young World in 2018. As one of the world's largest and most complex events, the Canadian capital was able to share its experiences from hosting in 2016.

Research investment supports innovations to help keep farm animals healthy

Ontario's government is supporting agriculture innovation by investing in research on livestock nutrition, biosecurity and production to help keep our farm animals healthy and safe. The \$1.1 million investment will help develop new livestock technologies, practices and on-farm solutions while fostering innovation and competitiveness in the livestock sector. "Our government is committed to advancing animal health and making the livestock sector more productive," said Ernie Hardeman, Ontario's Minister of Agriculture, Food and Rural Affairs. "This investment will provide farmers with the latest knowledge and tools they need to keep farm animals and food safe while continuing to be global leaders in the agriculture sector."

Through the Ontario Agri-Food Innovation Alliance, the province is funding livestock research to support the development of innovative products, approaches and best practices with research projects that include:

· Assessing health and precision technologies to improve dairy cow fertility. Investigating nutrition strategies to improve the health and growth of · pigs.

- · Research to guide antibiotic use in the goat industry.
- · Enhancing natural fertility in dairy cows through health and precision technologies.
- · A machine learning approach to illness surveillance in swine populations.
- · Assessing alternative feeds to improve health and productivity in chickens.

of Health, was at Hillcrest
Reactivation Centre to
announce that the government
is investing an additional \$155
million this year to expand
home and community care
services.

"Home and community care play a critical role in ending hallway health care," said Elliott. "By making these significant investments and supporting partnerships between home and community care providers and busy hospitals, patients will experience quicker transitions between receiving hospital care and returning home with the appropriate support they need to properly recover, while also making sure hospital beds are available for those who need them."

As a part of this investment, the government is providing \$45 million for targeted innovative integrated care models in high-need areas. "Certain areas in Ontario are experiencing higher-thanaverage rates of patients receiving care in

unconventional spaces," added Elliott. "By investing in targeted partnerships between hospitals and home and community care providers in these regions, we can tackle the challenge of hallway health care head on to ensure patients are receiving the high-quality care they expect and deserve."

By investing in more frontline patient care, the province can provide:

- · 1.8 million more hours of personal support services
- · 490,000 more nursing visits and 100,000 more therapy visits
- · Services in the community like homemaking, meals, transportation and caregiver supports
- · Additional direct community services for patients with acquired brain injury and people living in supportive housing. "Home Care Ontario applauds today's announcement of new funding for home and community care," said Sue VanderBent, CEO of Home Care Ontario. "This new money will help deliver more care at home, which is the quickest and most costeffective way to end hospital overcrowding. It will help people avoid hospital admissions altogether as well

as help people get home from hospital even faster. We commend the government for continuing to make home care a key priority."
