## **EXIM Releases Revised Strategic Plan for FY 2018-2022**

Reforms Allow EXIM to Keep America Strong by Empowering U.S. Businesses and Workers to Compete and Win Globally

Washington, D.C. - The Export-Import Bank of the United States (EXIM) today released its revised Strategic Plan for fiscal years (FY) 2018 - 2022. This plan outlines the agency's key goals and serves as a roadmap to fulfill its congressional mandate of supporting U.S. jobs by facilitating the export of "Made in the USA" goods and services.

The previous Strategic Plan for FY 2018 – 2022 cited a key goal of returning EXIM to full capacity. In May 2019, the U.S. Senate confirmed three members of the board of directors, returning the board to a quorum and allowing the export credit agency to resume full financing capacity. The revised Strategic Plan highlights priorities for EXIM to ensure the agency will continue to support U.S. jobs and promote economic expansion. Key strategies outlined will level the playing field for U.S. exporters, promote small businesses, minimize risk to taxpayers, and protect national security

interests. The plan also notes key reforms underway at the agency, including ensuring transparency and attracting and retaining the best talent. "It is an honor to work with President Trump and our administration colleagues to further our nation's economic and national security," said EXIM President and Chairman Kimberly A. Reed. "This revised Strategic Plan not only focuses on supporting U.S. jobs including in small businesses more pg 2

As an MRO solutions provider committed to continuously enhancing the service value it offers to the market and its customers, this month, Etihad Engineering, together with its partner EOS, received one of the first Airline MRO approvals from EASA for 3D printing using powder-bed fusion technology which will be used to design, produce and certify additively manufactured parts for the

aircraft cabin of the future.

Engineering, commented: "The launch of the new facility is in line with Etihad Engineering's position as a leading global player in aircraft engineering as well as a pioneer in innovation and technology. This provides lift to the follower aircraft allowing it to decrease engine thrust and therefore reduce fuel consumption in the range of 5-10% per trip.

The technical solution that Airbus is working on involves



The Abu Dhabi based airline has been serving Saudi Arabia since December 2004 and is currently celebrating its 15 years of flying to the Kingdom. Today, Etihad operates 84 weekly passenger frequencies from Abu Dhabi to Riyadh, Jeddah, Madinah, and Dammam using A320, A330, B777, and B787.

Etihad had recently expanded its codeshare with Saudia, placing its codeshare on flights to Peshawar, Multan, Port Sudan and Vienna. # ETIHAD BECOMES THE FIRST AIRLINE TO RAISE FUNDS TIED TO UNITED NATIONS SUSTAINABLE DEVELOPMENT GOALS

Partnership with First Abu Dhabi Bank and Abu Dhabi **Global Market** highlights UAE capital'sexpertise as a hub for sustainable financing :Etihad Airways, the national carrier of the United Arah Emirates, has become the first airline to secure funding for a project based on its compatibility with the Sustainable Development Goals of the United Nations. Through a partnership with First Abu Dhabi Bank and Abu Dhabi Global Market. the airline will borrow 100 million Euros (AED 404.2 million) to support expansion of the Etihad Eco-Residence, a sustainable apartment complex for the airline's cabin crew.

Adam Boukadida, Senior Vice President Treasury, Tax & Finance, Etihad Aviation Group, said the process to secure the loan hinged on a detailed international verification of the airline's sustainability credentials. "We are proud to be the first airline globally, and one of the first companies in the UAE, to obtain commercial funding based on our commitment to the Sustainable Development Goals of the United Nations," Mr Boukadida said. "This assessment will enable us to fund long-term leases of the new Eco-Residence complex, located in Abu **Dhabi's Masdar City** innovation precinct, and will serve as the foundation for Etihad to fund future sustainable initiatives." "It will also highlight the growing specialisation of Abu Dhabi as a centre of excellence for financing sustainable projects, at a time of increasing global demand for ethics-based



development." To support this financing, Etihad established a **Sustainable Development Financing Framework**, which specifies a range of projects for which funding can be provided. **Financing of these projects** must be linked to one or more of the Sustainable **Development Goals. Etihad** has identified seven priority categories - Green **Buildings**, Investment in Women, Biofuels, Reduction of Carbon Footprint, Waste Management and Recycling, Humanitarian Efforts, and Wildlife Protection. The Etihad Eco-Residence, a **LEED Platinum rated** building, met the requirements for two of the UN's 17 Sustainable **Development Goals – Goal 7,** Affordable and Clean Energy, and Goal 9, Industry, Innovation and Infrastructure. In addition, Etihad Aviation Group engaged Sustainalytics, a global leader in ESG research, ratings and analytics, to review the Etihad Sustainable Development **Financing Framework, and** confirm alignment with the **Sustainability Bond** Principles of the

International Capital Markets Association. Sustainalytics issued a Second Party Opinion verifying Etihad's sustainability credentials, a key condition to raising capital.

"Our decision to seek an independent review of our credentials demonstrates our commitment not only to sustainable development, but also to ensuring that we exercise global best practice." said Mr Boukadida. "The funding we have secured for this major project through our partnership with First Abu Dhabi Bank and Abu Dhabi **Global Market is not only** the first in global aviation, but also one of the first in the Middle East region," he said. "It highlights our commitment to innovation, and Abu Dhabi's capability to deliver it." Andy Cairns, Head of **Global Corporate Finance** at First Abu Dhabi Bank. said, "We are honoured to have led this inaugural SDG loan for Etihad Airways which evidences the company's commitment not only to its sustainability goals but also to innovative financing techniques. turnaround time which allows for the production of the required cabin parts during line maintenance.

The EOS machine operates with a total build volume of 340 x 340 x 600mm. The modular and highly productive system enables the tool-free manufacture of serial components, spare parts, functional prototypes and models directly from CAD data.

The second machine is the BigRep ONE, one of the largest, serial-built industrial thermoplastic extrusion 3D printers. Bringing additive manufacturing to MRO, the ONE is designed for manufacturing large parts, jigs and fixtures as well as moulds – on site and on demand.

"Our 3D printers have established 3D printing and AM as an innovative, addedvalue technology in the aviation industry. They offer an unprecedented level of precision, quality and speed, and enable us to use the highperformance, innovative printing materials the aviation industry requires", said Martin Back, BigRep Managing Director. "Together with Etihad Engineering, we will develop the full potential of AM. In the next phase, a BigRep PRO, the most advanced large-format FFF 3D printer will be installed.' The facility was officially opened in a ceremony attended by His Excellency Ernst Peter Fischer, German Ambassador to the UAE in recognition of the relationship between the German companies EOS and BigRep and the UAE's Etihad EngineeringEtihad Engineering first received EASA approval to 3D print with filament technology in 2017 and was the first airline MRO in the world to certify, print and fly 3D printed cabin parts. The latest approval, received in October 2019 covers powder bed fusion 3D printing technology.

## FAI Technik completes ADS-B and FANS installations on Bombardier Challenger 604s

FAI Technik GmbH, the expanding German MRO supplier and member of the FAI Aviation Group, has completed two FANS installations on two Bombardier Challenger 604s (D-AFAA and D-AFAG) during October/November. It has also just commenced a further installation, scheduled for completion by mid-December 2019. Simultaneously, FAI Technik GmbH has received an EASA-STC for a Garmin ADS-B solution for a Bombardier Learjet 60, designed by FAI Engineering in collaboration with FAI's Part 21-Design Partner S4A, located in Madrid, Spain. With three Learjet 60 ADS-B modifications already completed, FAI Technik is now seeking to modify another three Learjet 60 models before year end. This will mean that FAI's entire Air Ambulance fleet, comprising six Learjet 60s, plus four Challenger 604s, will be ready for unrestricted Transatlantic flying by the end of this year.

Its six other European based Learjet 60s are scheduled for ADS-B modification in the first and second quarters of 2020, respectively, in time for the EASA mandate by June 2020 About FAI Technik GmbH

# **Ontario Opening Cannabis Retail Market**

Province helping build safe and convenient retail system to combat illegal market TORONTO — The Government of Ontario is taking steps to move to an open market for retail cannabis stores beginning in January 2020. This will provide consumers with more choice and convenience and a safe, reliable supply of cannabis. "In response to the federal government's decision to legalize cannabis, our government is determined to open the cannabis market as responsibly as possible," said Attorney General Doug Downey. "We have said all along that opening more legal stores is the most effective way to combat the illicit market, protect our kids and keep our communities safe. That is our number one priority.' Removing the temporary cap on the number of private cannabis stores in the province

and eliminating prequalification requirements for prospective retailers are some of the key changes the government has made to cannabis regulations. Other amendments include:

Increasing the ability of licensed producers to participate in the retail market and allowing them to open a store at one of their facilities. These changes enable more capital, experience and capacity to enter the market and will help more legal stores open faster

Phasing in limits on the number of authorized stores a licence holder can have, to ensure fair access for retailers while creating medium and long-term market certainty.

Enabling retailers to sell additional cannabis-related items such as cannabis-related magazines and cookbooks. The Alcohol and Gaming

Commission of Ontario (AGCO) will begin accepting operator licence applications from prospective retailers on January 6, 2020, followed by store authorization applications on March 2, 2020. Store authorizations from this open application process are expected to be issued beginning in April, at an initial rate of approximately 20 per month. The province continues to have strict rules for private cannabis stores to help keep kids safe and ensure retailers behave with integrity. These include regulations that deny licences to anyone with certain cannabis-related offences or any association with organized crime. Regulations also require licence holders, cannabis retail managers and employees to complete approved training.

# **Ontario Amending Death Registration Regulations**

This will Offer Relief to Families in Distressing Situation

TORONTO - The Ontario government is amending the death registration process to ease the burden for families when faced with registering the death of a loved one in the absence of their remains. The regulatory amendment was announced earlier this week when Attorney General Doug Downey introduced the Smarter and Stronger Justice Act.

This was the situation for the family of Laura Babcock. In July 2017, an Ontario jury heard sufficient evidence to find Laura Babcock had been murdered, even though her remains were never found. Ms. Babcock's parents faced challenges to register her death on this basis, further contributing to the family's grief.

"Losing a loved one is devastating, and my heart goes out to the Babcock family in the face of such an awful tragedy," said Premier Doug Ford. "This is a straightforward way for our government to ease the burden on grieving families and ensure they never have to face the same difficult process as this family did." The Ministry of Government and Consumer Services, along with the Ministry of the Attorney General, explored changes to death registration requirements that would make the process less burdensome to the victim's family in these cases, while also maintaining the integrity of the death registration process. The amendment under the Vital Statistics Act will provide a simpler and faster method for families to get the closure that comes with a death certificate in tragic circumstances where there are no remains. This change will provide tools to assist in facilitating the registration of death where no physical remains are recovered. Court staff will also be provided with additional direction to ensure families have the necessary support in these very difficult situations. "I extend my deepest

sympathies to the Babcock family," said Lisa Thompson, Minister of Government and Consumer Services. "We are making changes to simplify the documentation that can be accepted to register a death in these devastating situations." "We want to ensure that in the future, the death registration process is less burdensome for families who experience a similar tragedy" said Attorney General Doug Downey. "Families in this situation are grief-stricken and should not have to deal with the difficult process imposed by the previous system." Once a death is registered in Ontario, information about the deceased is sent to various provincial and federal stakeholders who use this information to update their records accordingly. A delay in registering a death means correspondence may continue to be issued to the deceased. "I express my heartfelt condolences to the Babcock family," said Kinga Surma, MPP for Etobicoke Centre. "I hope these changes will bring closure to this family and bring relief to those who have experienced the loss of a loved one.'

### QUICK FACTS

In most cases, the remains of the deceased are examined by

a physician, nurse practitioner, or coroner who completes the Medical Certificate of Death with the cause of death information. The absence of remains in circumstances of peril does not allow for this process to be followed. The amendments to Regulation 1094 under the Vital Statistics Act will allow for a court order declaring an individual has died (Declaration of Death) to be used, along with a Statement of Death, to register a death where the courts have determined the deceased disappeared in circumstances of peril, and there are no

### Helping Ontario Farmers Improve the Environment

New application intake will support measures to benefit Lake Erie TORONTO - As part of their commitment to protecting our environment, the governments of Canada and Ontario will commit further funding support to help farmers make their operations more environmentally sustainable to improve water quality in the Lake Erie and Lake St. Clair watersheds.

Beginning January 15, 2020, applications will be accepted for a new intake of cost-share funding under the Lake Erie Agriculture Demonstrating Sustainability (LEADS) initiative. Funded through the Canadian Agricultural Partnership (the Partnership), the projects LEADS supports in 2020 will build on many previous investments by farmers and the governments to improve the sustainability of farming practices around Lake Erie and reduce phosphorus entering the connecting waterways. Eligible applications will be received and assessed on a continuous basis, while funding is available. "Canadian farmers are responsible stewards of the land, and our Government is working side-by-side with them to improve soil and water quality, and fight climate change," said the Honourable Marie-Claude Bibeau, federal Minister of Agriculture and Agri-Food. "The LEADS initiative is a critical next step in our collective effort to ensure the sustainability of the Lake Erie water basin.' "We're pleased to support our farmers in their careful stewardship of the land and help them make their operations even more environmentally sustainable,"

said the Honourable Ernie Hardeman, Ontario Minister of Agriculture, Food and Rural Affairs. "Our government is committed to working with farmers to build Ontario together, including protecting water quality in the Lake Erie watershed." Examples of projects eligible for support under LEADS include: Modifying equipment to

improve management of agricultural nutrients and to reduce soil compaction; Planting overwintering cover crops to improve soil health and reduce soil erosion losses: Planting vegetation and trees to provide a buffer between agricultural operations and waterways; and Retiring environmentally fragile lands from agricultural production and planting permanent vegetative cover to reduce the loss of soil and nutrients from these lands. Since June 2018, both the federal and provincial governments have committed cost-share support to approximately 2,500 projects through the Partnership to help eligible Ontario farmers, processors, businesses and sector organizations innovate and grow.

The LEADS initiative is available to farmers in the Lake Erie and Lake St. Clair watershed areas to support their actions to reduce the risk of nutrient loss and to improve farmland soil health. Since 2018, more than 560 projects have been approved under the regionally targeted LEADS initiative, with \$5.5 million committed through the Partnership to support completion of these on-farm

## **Investing in Community Safety Across the Province**

New grant program to support police services and local priorities

CAMBRIDGE — The Ontario government is providing police services across the province with the resources they need to combat crime and keep communities safe by investing \$195 million through the province's new Community Safety and Policing (CSP) Grant program over the next three years. Through the local priorities funding stream, 89 police services boards will be

allocated a total of \$181 million to address issues that were identified by their communities as local areas of focus. These include

collaboration between the police and community organizations to help individuals suffering from mental health issues and addictions (e.g., mobile crisis response teams), as well as programs to combat impaired driving, property crime and other public safety concerns. In addition, approximately \$14 million will be allocated to 18 police services boards under the provincial priorities funding stream to address gun and gang violence, sexual violence and harassment, and human trafficking. "Our police services and their partners know best what they need to combat crime in their communities," said Sylvia

Jones, Solicitor General. "The investment we are making today will help deploy additional frontline officers and take action where and when it is needed most." Of the \$195 million investment, approximately \$8.5 million will help Waterloo Regional Police Service expand its Community Oriented Response and Enforcement Teams and set up a new team under its Gang Intelligence and Enforcement Initiative. These teams will play a crucial role in strengthening community safety in the Waterloo Region and in ramping up the fight against gun and gang violence.

Ontario Legislature passes the Better for People, Smarter for Business Act

Another big step making life easier for people and businesses by removing regulatory barriers to job creation

TORONTO - Today, the Ontario Legislature officially passed the Better for People, Smarter for Business Act, 2019. The Act is part of the government's signature package to address red tape and modernize regulations to make life easier for people and business. The legislation will lower the cost of doing business by making it simpler and more costeffective to comply with regulations - leading to more jobs, higher wages and more opportunities for hardworking families. "Many regulations are in place for good reasons, like those that protect health. safety and the environment," said Sarkaria. "But at the same time, decades of government regulation have resulted in rules that are duplicative, outdated or unclear, causing businesses to spend time and money complying with rules that simply could be better. We're ensuring that Ontario's regulations are effective, targeted, clear and focused — while maintaining Ontario's high standards." The broader package includes consultations on how to help food banks and

community organizations with new, clarified regulations. This would allow them to focus on serving the most vulnerable among us. Other proposals would allow restaurants to decide whether or not to permit dogs on their patios, significantly increase the number of penalties for environmental violations and ensure that Ontarians are protected from drug shortages.

The Better for People, Smarter for Business Act supports various business sectors including agriculture, trucking, construction, forestry and mining. It streamlines and consolidates rules and requirements for quarries, farming and waste management. It also creates a one-stop shop for trucking safety and emissions inspections and hydroelectric dam approvals. "We heard from families and businesses that Ontario's regulatory burden is weighing them down," said Sarkaria. "This legislation will provide direct benefits to people in their everyday lives, while also improving Ontario's investment climate, restoring our competitive advantage, and helping reignite the economic growth that made Ontario the economic engine of Canada."
