COVID-19: UNWTO calls on tourism to be part of recovery plans

Tourism faces up to the COVID-19 challenge and public health is paramount due to the fundamental people-topeople nature of the sector. • A cross-cutting economic activity unlike any other, and an integral part of the Sustainable Development agenda, tourism will play a key role in future recovery efforts.

• UNWTO calls on governments, international organizations and donor agencies to include tourism as a priority in recovery plans and actions.

· The World Health Organization continues to advise against the application of travel or trade restrictions to countries experiencing COVID-19 outbreaks. Madrid, Spain, 6 March 2020 - In an update on the sector's response to the coronavirus COVID-19 outbreak, the World Tourism Organization (UNWTO) offers a first assessment pointing to a decrease in international arrivals and receipts in 2020. Public health measures need to be implemented in ways that minimize any unnecessary disruption to travel and trade. Since the start of the outbreak,

UNWTO has been working closely with the World Health Organization (WHO) to ensure this is the case. UNWTO has revised its 2020 prospects for international tourist arrivals to a negative growth of 1% to 3%, translating into an estimated loss of US\$ 30 to 50 billion in international tourism receipts. Prior to the COVID-19 outbreak, UNWTO predicted a positive growth of 3% to 4% for this year. This first assessment expects

This first assessment expects that Asia and the Pacific will be the worst affected region, with an anticipated fall in arrivals of 9% to 12%. Estimates for other world regions are currently premature in view of the rapidly evolving situation. UNWTO underscores that any estimate must be treated with caution and is likely to be updated. Preparing for recovery UNWTO calls for financial and political support for

recovery measures aimed at tourism, and to include support for the sector in the wider recovery plans and actions of affected economies. The impact of the COVID-19 outbreak will be felt across the UNWTO Secretary-General Zurab Pololikashvili furthermore stresses that "small and medium sized enterprises make up around 80% of the tourism sector and are particularly exposed with millions of livelihoods across the world, including within vulnerable communities, relying on tourism". Political and financial commitments are key to ensure that tourism can lead wider economic and social recovery, as proven in past disruptions on the back of the highly resilient nature of the sector and its ability to bounce back strongly. In recent decades, tourism has come of age, and is now firmly established as an important contributor to sustainable development, economic growth, employment and international understanding. As the UN agency responsible for tourism and sustainable development, UNWTO stands ready to provide guidance and support for recovery measures of its members, the private and public tourism sector, including organizers of tourism events and fairs.

World Health Organization

In 4 years, 494 attacks on health killed 470 patients and health staff in Syria

Every 4 days in 2019, a health facility in Syria was attacked. A majority occurred in the northwest, where the world's most urgent humanitarian crisis continues to unfold. March 2020. Geneva/Copenhagen/Cairo -The World Health Organization condemns in the strongest terms, attacks on health care that have been a hallmark of the complex humanitarian crisis in Syria that this month enters its tenth year.

'The data we can now reveal on attacks on health in Svria is a grim testament to a blatant disrespect for international humanitarian law and the lives of civilians and health workers," said Richard Brennan, WHO's Regional Emergency Director in the Eastern Mediterranean. Of all armed conflicts across the globe, Syria has for years been one of the worst examples of violence affecting health care. Intentionally attacking sites where the sick and wounded are treated, to either restrict or deny civilians access to health care, is prohibited under international humanitarian law Indiscrimate attacks in civilian areas can also result in damage to health care, reflecting a callous disregard for lives and welfare of the most vulnerable. "What is troubling, is that we've come to a point where attacks on health - something the international community shouldn't tolerate - are now taken for granted; something we have become accustomed to. And they are still taking place. Only 2 weeks ago, 2 hospitals in Idleb governorate were carried out, injuring 4 health workers and temporarily suspending services," said Brennan. A total of 494 attacks on health were confirmed between 2016 and 2019,1 of

which 68% or 337 attacks were recorded in Syria's northwest; among the last areas in the country that are not under government control. The data show that attacks on health in Svria peaked in 2016 and were lowest in 2019, likely due to the reduced size of the area where active fighting was taking place. The fact that the northwest - Idlib, Aleppo and Hama - has suffered the lion's share of attacks compared to other regions in Syria, is notable. In 2019, 82% occurred in the northwest, 49% in 2018, 58% in 2017 and 85% in 2016. The total death toll in attacks on health care in Syria between 2016 and 2019 is 470, peaking in 2016 with 241 confirmed deaths. The lowest number of deaths recorded was in 2019 at 54, again due to the reduced territory undergoing military operations. Northwest Syria represents the highest total numbers of deaths in those 4 years - 309 or 66%. In addition to the deaths, 968 people were injured by these attacks across Syria since 2016; many of whom have been left with permanent disabilities. "A clear example of how conflict impacts an individual's right to health is northwest Syria, where today only half of 550 health facilities remain open either due to insecurity, damage from previous attacks. threats of future attacks, or surrounding areas being completely deserted as people are forced from their homes," Brennan marks. "Health facilities are now the

least safe places in the area," said one physician, a few days after 2 hospitals in Darat Izza were hit in an airstrike on 17 February 2020. Another physician working in a child and maternity hospital in Harim in Idleb governorate, described to WHO how he and his medical team worked in constant fear of shelling. more pg 2

Madrid, Spain and Geneva, Switzerland, 26 February 2020 -As the current outbreak of the Coronavirus Disease (COVID-19) continues to develop, the World Health Organization (WHO) and the World Tourism Organization (UNWTO) are committed to working together in guiding the travel and tourism sectors response to COVID-19. On 30 January 2020, the Director-General of the World Health Organization (WHO) declared the outbreak of COVID-19 to be a Public Health Emergency of International Concern and issued a set of Temporary Recommendations. WHO did not recommend any travel or trade restriction based on the current information available. WHO is working closely with global experts, governments and partners to rapidly expand scientific

knowledge on this new virus, to track the spread and virulence of the virus, and to provide advice to countries and the global community on measures to protect health and prevent the spread of this outbreak.Cooperation is key The tourism sector is fully committed to putting people and their well-being first. International cooperation is vital for ensuring the sector can effectively contribute to the containment of COVID-19. UNWTO and WHO are working in close consultation and with other partners to assist States in ensuring that health measures be implemented in ways that minimize unnecessary interference with international traffic and trade. Tourism's response needs to be measured and consistent,

proportionate to the public health threat and based on local risk assessment, involving every part of the tourism value chain public bodies, private companies and tourists, in line with WHO's overall guidance and recommendations. UNWTO and WHO stand ready to work closely with all those communities and countries affected by the current health emergency, to build for a better and more resilient future. Travel restrictions going beyond these may cause unnecessary interference with international traffic, including negative repercussions on the tourism sector. At this challenging time,

Lebanon - Meeting between Jean-Yves Le Drian and his Lebanese counterpart (Paris -February 28, 2020)

Jean-Yves Le Drian, Minister for Europe and Foreign Affairs, received Nassif Hitti, Minister of Foreign Affairs and Emigrants of the Republic of Lebanon, today. The minister reaffirmed the strong ties of friendship between France and Lebanon and France's commitment to the Lebanese people in the context of the challenging circumstances facing the country. During this initial meeting, he reaffirmed that, three months after the holding of the meeting of the International Support Group for Lebanon (ISG), the Lebanese authorities needed to take action to address the challenges facing Lebanon, with the common interest of the Lebanese people as their sole concern. He underscored the urgent need to take a range of economic, social and political measures to respond to the aspirations expressed by the Lebanese people since October 17. Jean-Yves Le Drian underlined that it was up to the Lebanese authorities to implement a credible plan to allow the country to resolve the crisis. This is the basis on which France stands ready, together with its partners, to support Lebanon. The minister reiterated France's commitment to maintaining Lebanon's disassociation from regional crises, a prerequisite for ensuring the stability of the country and the region. He reaffirmed that France, today and in all circumstances. stands alongside the Lebanese people.

health facilities. The previous month, two thirds of the United Nations Security Council requested an inquiry based on the suspicion that making their location public through deconfliction had made these facilities a target and that some of the attacks had been deliberate. The Board of Inquiry has yet to present its findings. So far, in 2020, confirmed attacks on health in Syria are 9 - all of them in the northwest - resulting in 10 deaths and 35 injuries.

It stands ready to support any effort in this direction based on agreed international parameters and coming about through negotiations between the parties

Tunisia – Formation of the government (February 27, 2020)

France offers its congratulations to Elyes Fakhfakh and his government and its best wishes for their success, following yesterday's vote of confidence. The French authorities intend to pursue and strengthen our close dialogue with the new government, given the multilayered partnership that exists between our two countries and the important bilateral and multilateral milestones scheduled for 2020. Among other things, Tunisia will host the 18th Francophonie summit. We want to applaud the commitment of the outgoing government led by Youssef Chahed to strengthening our bilateral partnership.

Serbia – Meeting between Amélie de Montchalin and Jadranka Joksimovic, Minister for European Integration of the Republic of

Serbia (Paris - March 3, 2020)

Amélie de Montchalin, Minister of State for European Affairs, attached to the Minister for Europe and Foreign Affairs, will receive Jadranka Joksimovic, Serbia's Minister for European Integration, on March 3.

The meeting will provide an opportunity to discuss bilateral relations, which were given new impetus by President Macron's visit to Belgrade on July 15 and 16, 2019. The two ministers will also discuss the negotiations on Serbia's accession to the EU in the context of discussions at the Council of the European Union on the reform of the accession process in order to make it more credible, appealing and reversible.

France supports the strategic decision made by Serbia to join the European Union and stands alongside it while continuing to support its efforts to implement the necessary reforms, especially with respect to the rule of law, which is at the heart of the European project.

Paris - March 4, 2020 Guinea Bissau (March 4, 2020)

France shares the serious concerns expressed on March 1 about the situation in Guinea Bissau by the Economic Community of West African States (ECOWAS), whose critical role it commends.

France urges Guinea Bissau's defense and security forces to distance themselves from politics and calls on all stakeholders to exercise restraint and to ensure respect for the legal and institutional framework in order to resolve the electoral dispute

United Nations – Resignation of Ghassan Salamé (March 2, 2020)

France noted with regret the announcement of the resignation of Ghassan Salamé, Special Representative of the UN Secretary-General for Libya. Ghassan Salamé has carried out his mission with competence and conviction since June 2017. We commend his efforts to promote a ceasefire and the launch of inter-Libyan dialogue under UN auspices.

France hopes that this momentum can be maintained and calls on all stakeholders to commit to a lasting ceasefire,

North Korea – Firing of ballistic missiles (March 2, 2020)

North Korea announced on March 2 that it had conducted further ballistic missile launches

France reiterates its condemnation of these repeated launches which undermine regional security and stability and constitute violations of the relevant UN Security Council resolutions. France calls on North Korea to comply with the UN Security Council resolutions, to immediately engage in good faith in a process to ensure the complete, verifiable and irreversible dismantlement of its weapons of mass destruction and ballistic missile programs and to refrain from any form of provocation.

Paris - March 5, 2020

Qatar – Meeting between Jean-Yves Le Drian, Minister for Europe and Foreign Affairs, and his counterpart (March 4, 2020)

Jean-Yves Le Drian, Minister for Europe and Foreign Affairs, received his Qatari counterpart, Mohammed bin Abdulrahman Al Thani, Deputy Prime Minister and Minister of Foreign Affairs of Qatar, yesterday.

Jean-Yves Le Drian and his interlocutor signaled their attachment to the partnership between France and Qatar and underscored the need to continue to strengthen it. They notably welcomed the development of our economic exchanges and our cooperation in the cultural sphere in the context of the Qatar-France 2020 Year of Culture.

The ministers discussed the regional crises in the Middle East, regarding which our two countries engage in sustained and regular dialogue. With respect to Libya, Jean-Yves Le Drian and his counterpart reaffirmed the need for a lasting ceasefire that will be

upheld by all parties and for the swift implementation of the priorities outlined in the conclusions adopted in Berlin on January 19, notably the launch of a representative and inclusive inter-Libyan dialogue, involving all of Libya's neighbors and the regional partners. With respect to Syria, they expressed their shared concern regarding the dire humanitarian situation in the northwestern part of the country, as well as the risk of regional escalation. They agreed on the urgent need for a ceasefire and the need for a political solution in order to find a lasting solution to the crisis.European Union - Jean-Yves Le Drian's participation in the informal meeting of foreign affairs ministers and the Foreign Affairs Council (Zagreb - March 5-6, 2020)Jean-Yves Le Drian, Minister for Europe and Foreign Affairs, will take part in the informal meeting of EU foreign affairs ministers in Zagreb on March 5 and the extraordinary session of the Foreign Affairs Council the following day.

During the informal meeting on March 5, the ministers will discuss relations between the EU and Russia as well as relations between the EU and Turkey. With respect to Russia, the discussion should initiate a substantive debate on the relationship, with due consideration for the five guiding principles agreed upon in 2016 in order to steer relations between the EU and Russia. With respect to the discussion on Turkey, the minister will stress the need for a firm and demanding dialogue on the different aspects of the relationship between the EU and Turkey, including with respect to the crises in Syria and Libya.

An extraordinary formal meeting of the Foreign Affairs Council will take place on March 6 to address the crisis triggered by the offensive by the Syrian regime and its supporters, notably its Russian supporters, in the Idlib region. Jean-Yves Le Drian will reexamine the serious political, humanitarian, migration and security consequences of this crisis. He will reaffirm the importance of European unity in order to work toward a deescalation in Syria and to address the suffering of the civilian populations by strengthening European humanitarian assistance. The minister will call for the

rejection of any exploitation of the migration issue by Turkey while responding to the needs of the refugees in the region.

With respect to the concerns relating to the Coronavirus in EU countries, the ministers will also discuss this issue in order to reaffirm the need to strengthen coordination at the European level regarding the exchange of information, health measures, relations with third countries and public communication. These topics will also be included on the agenda of the extraordinary meeting of the EU Health Council on March 6 in Brussels.North Korea Ballistic missile launches (March 2, 2020)

We were concerned to learn of reports of new ballistic missile launches by North Korea on March 2.

France reaffirms its condemnation of these repeated launches, which undermine regional security and stability and violate pertinent UN Security Council resolutions. France calls on North Korea to comply with Security Council resolutions, to engage immediately and in good faith in a process of complete, verifiable, irreversible dismantlement of its WMD and ballistic missile programs, and to refrain from any provocation.

COVID-19-Israel

Does Israel's decision to no longer authorize French citizens to enter its territory due to fears of the spread of COVID-19 seem proportionate to the epidemiological situation in France? Is this the first time French citizens have been prohibited from entering a foreign territory due to the coronavirus?

As you know, the situation is very fluid and the authorities in each country concerned are taking measures related to the COVID-19 crisis.

Our compatriots are advised to consult the Travel Advisory on the France Diplomatie site (https://www.diplomatie.gouv.f r/fr/conseils-aux-voyageurs/), which is regularly updated based on the public health recommendations issued by the Ministry for Solidarity and Health. We recommend that French citizens who are traveling register on the Ariane portal in order to receive alerts.

We urge French residents living outside the country to sign up on the registry of French nationals abroad and to

update their contact information (cell phone numbers, email addresses) as necessary with local consulates.

COVID-19 – North Korea

Will representatives of the French Cooperation Office in North Korea be evacuated due to the risks linked to COVID-19, and if so, to which country?

Since late January, North Korea has taken drastic quarantine measures targeting foreign delegations and seriously hindering the operations of the French Cooperation Office in Pyongyang. In these circumstances, and in conjunction with our European partners, it was decided to temporarily close the French Cooperation Office until these measures are eased.

France continues to closely monitor the situation on the ground, and strongly advises French nationals not to travel to North Korea.

Situation of Fariba Adelkah and Roland Marchal

Information concerning the health of two French researchers detained in Iran is increasingly alarming. Both of them are cut off from the world and do not have access to the care they need, according to their support committee. Do you still have access to Roland Marshal, and what is their health status, according to your information?

We are following the situation of our two compatriots with the utmost attention and are concerned by the state of their health.

We are working relentlessly to obtain regular consular access, in line with Iran's international commitments, and to secure their immediate release

Indian Ocean Commission – Visit by Jean-Baptiste Lemoyne (March 6-9, 2020)

Jean-Baptiste Lemoyne, Minister of State attached to the Minister for Europe and Foreign Affairs, is visiting the Seychelles from March 6 to 9 to represent France at the Council of Ministers of the Indian Ocean Commission (IOC), which brings together five member states: the Union of the Comoros, France on behalf of Réunion, Madagascar, Mauritius and the Seychelles.

This visit will provide an opportunity to demonstrate our commitment within the IOC while underscoring the importance to France of its neighborhood relations in the Indian Ocean, as reaffirmed by Jean-Yves Le Drian, Minister for Europe and Foreign Affairs, during his recent visit to Mauritius, Madagascar and Mozambique. The Council of Ministers of the Indian Ocean Commission will formally adopt the revised Victoria Agreement, which replaces the general cooperation agreement between the member states of the Indian Ocean Commission of January 10, 1984, as well as the additional protocol of 1989. This text reaffirms the IOC's identity

as a regional neighborhood organization, reaffirms the unifying role of the French language and sets out the criteria for the granting of observer status.

During this visit, Jean-Baptiste Lemoyne will be received by Danny Faure. President of the Sevchelles: he will meet with Vincent Mériton, Vice President and Minister of Foreign Affairs. and Didier Dogley, Minister for Tourism, Civil Aviation, Ports and Marine. The minister of state will underscore the importance of our geographic and strategic proximity in the regional context of the southwest Indian Ocean in the areas of maritime security, the fight against climate change and the development of the blue economy, including from an Indo-Pacific perspective.

Jean-Baptiste Lemoyne will also visit the facilities of the port of Victoria, whose renovation is being supported by the French Development Agency, in order to promote French expertise in the field of port management. In an archipelago, where 30% of GDP is dependent on tourism, the minister of state will meet with French professionals in this sector, which offers investment opportunities

Ukraine – Opening of the flight MH17 trial (The Hague - March 9, 2020)

The opening of the trial on March 9 in The Hague of the four suspects in the downing of flight MH17 on July 17, 2014, is an important step toward establishing the facts and bringing justice to the families and friends of the victims.

France reaffirms its support for the member states of the joint investigation team. It calls on Russia to fully cooperate with the Dutch judicial authorities, in accordance with UNSCR 2166.

Iran

You triggered the Iranian nuclear agreement's dispute resolution mechanism in early January. Since November, enriched uranium stockpiles have tripled, and the IAEA separately accused Iran of responding to a certain number of questions in connection with the possibility of undeclared nuclear material and activities, and of refusing access to two sites. Do you believe Iran is prepared to resolve the disputes it has with you?

As the International Atomic Energy Agency confirmed in its quarterly report, issued on

March 3, Iran is continuing to implement measures counter to the JCPoA, particularly with respect to the accumulation of low-enriched uranium as well as research and development.

These actions by Iran have serious consequences in terms of proliferation. That is why France, along with its E3 partners, triggered the JCPoA's dispute resolution mechanism on January 14, to open a space for dialogue, in line with the agreement, in order to find a solution that would make it possible to preserve that agreement. Discussions were initiated and the dispute examination timeline was extended on January 24 following an agreement among the participants. Our aim remains Iran's total return to compliance with the commitments set forth in the JCPoA.

As President Macron emphasized on March 3, France urgently calls on Iran to cooperate with the IAEA as it carries out its mission to verify Iran's nuclear obligations. France supports the Agency's impartial, professional work, as the minister assured its director general, Rafael Grossi, during his visit to France on March 3.

Syria

Can you comment on the ceasefire agreement concluded by the Russian and Turkish presidents, Vladimir Putin and Recep Tayyip Erdogan, in Idlib province, which entered into force on Friday?

France, together with its EU partners, takes note of the agreement reached yesterday by Russia and Turkey (see https://www.consilium.europa.e u/fr/press/pressreleases/2020/03/06/statementof-the-foreign-affairs-councilon-syria-and-turkey/). It is crucial that this agreement lead to an effective implementation on the ground of an immediate, lasting and verifiable cessation of hostilities.

We reiterate our call to guarantee full compliance with international humanitarian law, the protection of civilian populations, and unfettered access to humanitarian aid.

On both the national and European levels, France is stepping up its humanitarian assistance to civilians in the Idlib region, at a time when nearly a million people have been displaced and are living in extremely harsh conditions.

France reiterates that only a negotiated political settlement under the auspices of the UN, in line with Security Council Resolution 2254, can put in place the conditions for a lasting solution to the Syrian crisis.Côte

d'Ivoire

What do you think of President Ouattara's statement that he would not run in the presidential election?

France applauds the announcement by President Alassane Ouattara of Côte d'Ivoire that he would not be a candidate in the 2020 presidential election, and his desire to thereby open the way to a new generation of Ivorians.

This decision can only facilitate the holding of consensus-based, inclusive elections in Côte d'Ivoire. In this regard, France applauds the mobilization of efforts by the EU and the Organisation Internationale de la Francophonie, which will support the Ivorian electoral process and help facilitate the emergence of a national consensus.

This announcement bolsters the provision enshrined in the constitutions of all ECOWAS nations limiting presidents to two terms in office.

Switzerland – Meeting between Jean-Yves Le Drian and his counterpart, Ignazio Cassis (Paris - March 9, 2020)

Jean-Yves Le Drian, Minister for Europe and Foreign Affairs, will receive Ignazio Cassis, Federal Councillor and Head of the Federal Department of Foreign Affairs of the Swiss Confederation, today.

The ministers will discuss the key international issues on which our countries are cooperating, notably including the situation in the Middle East. The minister and his interlocutor will reaffirm our two countries' attachment to the preservation of strong and effective multilateralism.

Jean-Yves Le Drian and Ignazio Cassis will also take stock of the forthcoming meetings focusing on relations between the EU and Switzerland.

The minister will discuss with his interlocutor our trusting and vibrant bilateral relations, especially in the border regions where our populations share catchment areas, the management of which requires close coordination between our two countries. The ministers will exchange views on the progress of negotiations relating to the management of water resources in the Rhone basin.

During this meeting Jean-Yves Le Drian and Ignazio Cassis will discuss the international response to the coronavirus (COVID-19) crisis.

Bilateral relations between France and Switzerland are close and longstanding. We engage in regular political dialogue; the volume of our trade (€31 billion in 2018) and the development of our cross investment reflect the mutual trust between our companies and our investors.

Tourism – Special meeting of the executive board of the Tourism Sector Committee convened by Jean-Baptiste Lemoyne (March 10, 2020)

Jean-Baptiste Lemoyne, Minister of State attached to the Minister for Europe and Foreign Affairs, has convened a special meeting of the executive board of the Tourism Sector Committee on Tuesday, March10 to discuss the consequences of the COVID-19 epidemic.

Introduced by the Prime Minister at the last Interministerial Tourism Council, the Tourism Sector Committee is an umbrella organization for all tourism professionals (government agencies, businesses, federations, professional associations, unions). It gives tourism professionals a voice in the development of tourism policies. This committee also facilitates the coordination of responses to exceptional situations affecting the sector, such as the coronavirus.

The purpose of tomorrow's meeting is to review the situation with professionals and to look at the consequences of the epidemic on this sector, especially in terms of visitor numbers, economic repercussions and jobs. It will highlight the measures taken by the government and facilitate the coordination of actions and responses by the various stakeholders.

Sudan – Attack targeting the Sudanese Prime Minister (March 9, 2020)

France condemns in the strongest possible terms this morning's assassination attempt against Sudanese Prime Minister Abdalla Hamdok and his convey in Khartoum. It calls for a thorough investigation into the circumstances and perpetrators of this attack.

France reiterates its full confidence in the efforts of Prime Minister Hamdok and Sudan's transitional authorities to rebuild the country and set it on the path of peace and democracy.

Standing by the Sudanese authorities, it reaffirms its commitment to ensuring the success of the democratic transition that must steer the country toward free elections in 2022.

taking inventory of the personal protective equipment (PPE) currently in our jurisdiction, and planning for what would additionally be required in the event of an outbreak," said Friesen. "Ensuring staff throughout the health system have access to the equipment and supplies required for safe patient care and their own personal protection is a priority."

Manitoba Health, Seniors and Active Living (MHSAL) is comanaging a provincially coordinated Incident Management Structure to ensure appropriate planning, preparation, mitigation and response to the evolving COVID-19 situation, the minister added. While Manitoba has an adequate supply of PPE at this time, this purchase will ensure the province is well positioned to manage any additional demand on resources that would accompany potential or confirmed cases of COVID-19 in Manitoba.

Current inventory of PPE supplies is being closely monitored, and regions and sites have been asked to take steps to ensure supplies of PPE, including procedure/surgical masks and N95 respirators, are maintained and that providers and staff are aware of their appropriate clinical use.

The purchase will help to ensure patients, staff, and frontline health workers, have appropriate protective equipment at a competitive price. The determination of the volume of supplies needed is undertaken collaboratively with the assistance of the Public Health Agency of Canada. Most personal protective equipment used in clinical environments will not spoil.

Based on current planning assumptions, including supplies required by Manitoba's regional health authorities, service delivery organizations, personal care homes and feefor-service clinics, the projected cost is an estimated \$35.2 million.

PPE supplies are being utilized as health-care facilities and sites across the province in line with clinical recommendations. This includes use by staff of gloves, gowns, procedure or surgical masks and face/eye protection when dealing with any patients who have flu-like symptoms (cough, fever, difficulty breathing). Procedure or surgical masks are also provided to patients who show these symptoms, as well as anyone accompanying them.

Staff performing certain procedures are required to wear an N95 respirator in addition to eye-protection, gloves and a gown. Efforts to ensure staff are appropriately trained and fittested for the N95 are underway across the province.

"The government and public health officials are reminding Manitobans the risk of acquiring COVID-19 in Manitoba remains low, but is increasing given events occurring in Canada and around the world. We must continue to prepare for this virus in Manitoba," said Dr. Brent Roussin, Manitoba's chief public health officer.

The Manitoba government is working with Shared Health, Manitoba's regional health authorities and service delivery organizations as well as the Public Health Agency of Canada to share information and best practices.

Common personal prevention and preparedness measures for viruses such as COVID-19 and influenza include regular hand washing with soap and warm water or an alcohol-based hand cleanser. Additional precautions include covering your mouth and nose when coughing and sneezing, and staying home when you are sick, regardless of recent travel. Avoid close contact with anyone showing symptoms of a respiratory illness, such as coughing or sneezing

3,200 More Manitobans Employed in February Strong Start to 2020 with Employment IncreasingBy 9,700: Fielding and Eichler

Manitoba's employment levels are off to a strong start in 2020, according to the latest report from Statistics Canada, Finance Minister Scott Fielding and Economic Development and Training Minister Ralph Eichler announced today.

"Our government is moving forward on our commitment to grow Manitoba's economy and create 40,000 new jobs over the next four years by fixing our finances and making the province an attractive place to do business," said Fielding. "Manitoba's labour market remains strong as shown by our solid track record to date." The latest figures show an

employment increase of 3,200 in February in Manitoba. It follows an increase of 6,500 in January, resulting in approximately 9,700 more Manitobans working in the first two months of 2020. According to the latest figures, Manitoba increased by more than double the national average. The increase in employment in February was accompanied by a decline in Manitoba's unemployment rate to five per cent, down from 5.1 per cent in January and 5.3 per cent in 2019. Manitoba continues to have the second lowest unemployment rate among Canadian provinces.

"We are working with industry and employers to ensure Manitoba workers will have the knowledge and skills they need to meet the needs of in-demand careers now and in the future," said Eichler. "This is proving to be an effective strategy to continue job market growth." The province's labour force has increased by 2,800 workers, a 0.4 per cent increase, while the country's rate as a whole increased by 0.2 per cent. Compared to the previous February, the labour force increased 1.3 per cent in Manitoba.
