#### **UNWTO and Italy Look Ahead as Official Visit Marks Restart of European Tourism**

he leadership of the World Tourism Organization (UNWTO) is on its first official visit to a Member State since restrictions on travel were introduced in response to COVID-19. The four-day trip to Italy (1-5 July) comes as the United Nations specialized agency for tourism guides the sector's restart and destinations across the Schengen Zone open their borders to tourists once again. Throughout the COVID-19 crisis, UNWTO has led tourism's response through a series of highlevel virtual meetings, uniting the sector, advocating for political and economic support and working with Member States to mitigate the impact of the pandemic and lay the foundations for recovery. Now, as borders in some parts of the world are carefully reopening back to tourism, UNWTO Secretary-General Zurab Pololikashvili is meeting face-toface with political and tourism leaders to change gears. The official visit to Italy marks the start of this shift, comprising a series of high-level meetings in Rome, Milan and Venice. Italy "world tourism leader" Secretary-General Pololikashvili said: "Italy is a world tourism leader, a strong ally of UNWTO and committed to making tourism a pillar of sustainable economic development. We must build on the determination and solidarity that characterized our joint response to the crisis to grow back stronger and better with sustainability and innovation among our most important guiding principles." In Rome, Mr Pololikashvili held meetings at the highest levels of government. To further strengthen



the bilateral collaboration on the road ahead to reactivate tourism and its economic and social benefits, was the connecting thread of the meetings held with Prime Minister Giuseppe Conte, Ministers of Culture, Cultural Heritage and Tourism, Dario Franceschini and of Foreign Affairs Luigi Di Maio, and the city's Mayor Virginia Elena Raggi. The UNWTO delegation also met with Cardinal Parolin of the Vatican City, building on last year's audience with Pope Francis.

In Milan, the Secretary-General met with Mayor Guiseppe Sala advancing the 2nd UNWTO Sports Tourism Start-Up Competition as the city prepares for the 2026 Winter Olympics and with the President Attilio Fontana of the Lombardy region. In addition to learning of Italy's response to the COVID-19 pandemic, the official visit also offered the opportunity to look to the future and further UNWTO's priorities of making tourism more sustainable, resilient and innovative. On the opening day of the trip, Rome Fiumicino Airport was presented with a special plaque as UNWTO recognized its commitment to sustainability. Furthermore, all three cities were formally invited to become part of the UNWTO League of Cities for Sustainable Tourism Initiative.

New Special Ambassadors for Responsible Tourism Appointed The official visit also presented the opportunity for UNWTO to highlight the role gastronomy and fashion, two of Italy's most celebrated industries, can play in growing tourism and making the sector more diverse and relevant. In recognition of their work, acclaimed chef Gino Sorbillo and fashion designer Giorgio Armani were appointed UNWTO Special Ambassadors for Responsible Tourism. In their new roles, they will use their status and influence to promote UNWTO's work in guiding tourism in these challenging times and highlight the sector's important role as an economic driver, leading employer and promoter of unique cultural heritage

WHO: access to HIV medicines severely by COVID-19 as AIDS response stalls

Countries seek innovative ways to mitigate the impact of disruptions and keep services going Seventy-three countries have warned that they are at risk of stock-outs of antiretroviral (ARV) medicines as a result of the COVID-19 pandemic, according to a new WHO survey conducted ahead of the International AIDS Society's biannual conference. Twenty-four countries reported having either a critically low stock of ARVs or disruptions in the supply of these life-saving medicines.

The survey follows a modelling exercise convened by WHO and UNAIDS in May which forecasted that a six-month disruption in access to ARVs could lead to a doubling in AIDS-related deaths in sub-Saharan Africa in 2020 alone

In 2019, an estimated 8.3 million people were benefiting from ARVs in the 24 countries now experiencing supply shortages. This represents about one third (33%) of all people taking HIV treatment globally. While there is no cure for HIV, ARVs can control the virus and prevent onward sexual transmission to other people.

A failure of suppliers to deliver ARVs on time and a shut-down of land and air transport services, coupled with limited access to health services within countries as a result of the pandemic, were among the causes cited for the disruptions in the survey. "The findings of this survey are deeply concerning," said Dr Tedros Adhanom Ghebreyesus, WHO Director-General. "Countries and their development partners must do all they can to ensure that people who need HIV treatment continue to access it. We cannot let the COVID-19 pandemic undo the hard-won gains in the global response to this

Stalled progress
According to data released today from UNAIDS and WHO, new
HIV infections fell by 39%
between 2000 and 2019. HIVrelated deaths fell by 51% over the same time period, and some 15
million lives were saved through the use of antiretroviral therapy.

However, progress towards global targets is stalling. Over the last two years, the annual number of new HIV infections has plateaued at 1.7 million and there was only a modest reduction in HIV-related death, from 730 000 in 2018 to 690 000 in 2019. Despite steady advances in scaling up treatment coverage – with more than 25 million people in need of ARVs receiving them in 2019 - key 2020 global targets will be missed. HIV prevention and testing services are not reaching the groups that need them most.

WHO guidance and country action COVID-19 risks exacerbating the situation. WHO recently developed guidance for countries on how to safely maintain access to essential health services during the pandemic, including for all people living with or affected by HIV. The guidance encourages countries to limit disruptions in access to HIV treatment through "multi-month dispensing," a policy whereby medicines are prescribed for longer periods of time – up to six months. To date, 129 countries have adopted this policy. Countries are also mitigating the impact of the disruptions by working to maintain flights and supply chains, engaging communities in the delivery of HIV medicines, and working with manufacturers to overcome logistics challenges

New opportunities to treat HIV in young children At the IAS conference, WHO will highlight how global progress in reducing HIV-related deaths can be accelerated by stepping up support and services for populations disproportionately impacted by the epidemic, including young children. In 2019, there were an estimated 95 000 HIV-related deaths and 150 000 new infections among children. Only about half (53%) of children in need of antiretroviral therapy were receiving it. A lack of optimal medicines with suitable


pediatric formulations has been a longstanding barrier to improving health outcomes for children living with HIV.Last month, WHO welcomed a decision by the U.S. Food and Drug Administration to approve a new 5mg formulation of dolutegravir (DTG) for infants and children older than 4 weeks and weighing more than 3 kg. This decision will ensure that all children have rapid access to an optimal drug that, to date, has only been available for adults, adolescents and older children. WHO is committed to fast-tracking the prequalification of DTG as a generic drug so that it can be used as soon as possible by countries to save lives. "Through a collaboration of multiple partners, we are likely to see generic versions of dolutegravir for children by early 2021, allowing for a rapid reduction in the cost of this medicine," said Dr Meg Doherty, Director of the Department of Global HIV, Hepatitis and STI Programmes at WHO. "This will give us another new tool to reach children living with HIV and keep them alive and healthy." Tackling opportunistic infections Many HIV-related deaths result from infections that take advantage of an individual's weakened immune system. These include bacterial infections, such as tuberculosis, viral infections like hepatitis and COVID-19, parasitic infections such as toxoplasmosis and fungal infections, including histoplasmosis. Today, WHO is releasing new guidelines for the diagnosis and management of histoplasmosis, among people living with HIV. Histoplasmosis is highly prevalent in the WHO Region of the Americas, where as many as 15 600 new cases and 4500 deaths are reported each year among people living with HIV. Many of these deaths could be prevented through timely diagnosis and treatment of the disease. In recent years, the development of highly sensitive diagnostic tests has allowed for a rapid and accurate confirmation of histoplasmosis and earlier initiation of treatment. However, innovative diagnostics and optimal treatments for this disease are not yet widely available in resource-limited settings.

passengers as and when they need, from their local smaller airfield instead of the main well known business jet hubs, they will also get closer to the final destination saving an incredible amount of time

Charter Brokers need to consider smaller regional airports more too. I have previously tested this by giving a post code in the middle of the Cotswolds and been offered flights to Bristol or Birmingham, when Gloucestershire, Cotswold and Oxford Airports are much closer and convenient. The smaller regional airports also need to play their part and promote the benefits of business aviation locally. Earlier this year I attended a business dinner in Cheltenham sitting with many high net wort individuals and local business leaders. Only one person had chartered an aircraft once before and despite Gloucestershire Airport being only four miles from where we were in Cheltenham, no one else in the room realised that business aviation existed.

We are all anticipating business aviation seeing a surge in demand not only for connectivity reasons reassurance of travelling with known colleagues and family but also due to the lack of airline routes, capacity and reliability issues. The airport terminal experience is not going to be a pleasant one for quite some time with increased check-in time, longer queues, shortage of facilities and of course the increased risk of infection.

As we begin the bounce back, let us all fully consider the full range of regional airports that are available to business and private aircraft. If you are a broker, just look little closer to see if there is a smaller and closer regional airport that you can use as there are many. If you are a regional airport owner, open the gate, step outside and tell your local community of your incredible facility with flexible flying right from their doorstep. One new customer is an additional movement, airport fee and fuel sale. Let's break the mould, shake off the reactive past and be ready to rebuild.

inspection tasks and landing gear restoration, additional hourly inspections were completed, as well as, multiple service bulletins to inspect for and correct flap corrosion. In the new fully computerised and climate controlled state-of-the-art paint shop, which opened this March at the Canadian company's headquarters, paint work touch ups rejuvenated the fuselage.

With most early production Global aircraft still operating Kliethermes says the team is pleased to be supporting future inspections. "As a Bombardier Authorized Service Facility, we

are very well positioned to support owners of this airframe. We have a highly motivated and experienced maintenance workforce that understands the intricacies of these detailed checks: we have the infrastructure with eight spacious hangars in North America enabling easy fuselage access; and a dedicated Global tail-dock designed to support work on the Global platform. We also have our avionics, paint and interiors team standing by to support a variety of aircraft upgrades in parallel. Owners appreciate the ability to have all the work conducted in one location as it significantly minimises downtime," concludes Kliethermes

The new window increases terrestrial visibility to ensure accurate data collection to support

The multipurpose aircraft is available for mapping missions for private individuals, governmental associations and corporations who want to establish the geospatial baseline of an area's topography, natural landscape, built environment and more.

Following a successful series of mapping flights performed in Denmark this May, the aircraft will begin mapping operations throughout the whole European continent this summer. Zeusch is also planning on expanding the company's reach beyond Europe. Managing Director Herman van Kranenburg says, "Mapping is a seasonal

activity requiring clear skies and good weather to support the systematic collection of topographical data. To minimise aircraft downtime, we plan to fly the aircraft in Europe during the spring and summer, and then relocate it to regions where the weather is more suitable for mapping during our winter

PH-ZAZ complements the existing Zeusch fleet of two King Air C90A types of which one is outfitted for broadcast relay missions and the other for mapping. Previously registered in the UK as G-MEDZ, and operated by Zeusch, PH-ZAZ has been repositioned to Lelystad Airport, home of Zeusch Aviation. A second, recently acquired Beechcraft B200 Super

King Air is currently being ferried from North America to The Netherlands where it will join the trio of King Airs to make a total of four aircraft in the Zeusch fleet.

"We are delighted to have placed our first aircraft on our national registry; it's a real achievement for our young company. We're

also pleased to maintain our loyalty to the King Airs as there are positive economics associated with keeping a consistent fleet type. #### FEI General Assembly 2020 moves online



The FEI General Assembly 2020. which was due to be held in Johannesburg (RSA) in November, has been cancelled and will now be held online due to Covid-19 social distancing requirements and travel The decision was approved by the FEI Board during its three-day videoconference meeting this week, and the Board also gave its unanimous support to allocate next year's FEI General Assembly to Johannesburg. "The safety of our community is our highest priority and although it is regrettable, cancelling our inperson General Assembly this year and going online was the responsible thing to do," FEI President Ingmar De Vos said. "We are very grateful to the National Federation of South Africa for the support and flexibility they have shown, as well as their willingness to host our General Assembly next year when the situation will hopefully have improved for everyone. "We are lucky to live in a time where it is possible to meet virtually, even though face-toface meetings and discussions keep us together as a community." With the pandemic legally defined as "force majeure" in

Switzerland, the country's Federal

government has adopted ad hoc temporary measures to facilitate the organisation of General Assembly meetings for Swiss based associations like the FEI. Under these special regulations, the FEI is permitted to hold its General Assembly electronically. Other large international gatherings, including next month's IOC Session, will also be held online.

The FEI is currently considering a number of electronic solutions for running the General Assembly online and will communicate these to National Federations in due course

"While we are of course disappointed not to be able to hold the FEI General Assembly in South Africa this year, we appreciate the confidence that the FEI has shown to us by giving us the opportunity to host the General Assembly next year," President of the National Federation of South Africa Adv Willem Edeling SC said

"It will be the first time that an international equestrian gathering of this scale will be held in South Africa and we look forward to welcoming delegates from around the world to our world class meeting facilities. 2021 is the centenary of the FEI, and we feel privileged that our event will form part of the 100-year celebrations."

Estonia / Sweden – Visit by Amélie de Montchalin to Tallinn and Stockholm (July 1-2, 2020) Amélie de Montchalin, Minister of State for European Affairs, attached to the Minister for Europe and Foreign Affairs, is visiting Estonia and Sweden from July 1 to 2

This visit is taking place in the run-up to the European Council from July 17 to 18 in order to establish the conditions necessary for an ambitious agreement on the European recovery plan. The Minister of State will reaffirm the

importance of reaching an agreement in July in the face of the economic and social emergency and will underscore the need to include budgetary allocations of at least 500 billion in support of the sectors and regions most affected by the crisis. In this context, the budget must also be reviewed to ensure coherence with the EU's political goals through the creation of new own resources consistent with our environmental goals. This recovery must be part of a project to rebuild Europe, and the Minister of State will therefore speak with her partners about holding the Conference on the Future of Europe as soon as possible, enabling citizens to take part in discussions on the lessons to be learned from the crisis. Also on the agenda is the importance of properly

coordinating border measures—more essential than ever for European countries as we emerge from the crisis—as well as strengthening European mechanisms to protect the rule of law.

In Tallinn, the Minister of State will meet with Foreign Minister Urmas Reinsalu and her counterpart, Märt Volmer. A joint statement on European issues and a specific statement on French-Estonian cooperation on cybersecurity will also be adopted on this occasion.

"From farm to table, ensuring that all Canadians have access to affordable and nutritious food is a priority for our government," said Bibeau. "This project helps give Manitobans the tools and knowledge they need to make healthy meals for their families, while supporting our local food farmers. We will continue to work side-by-side with the province to help shape a healthier and more prosperous future for Manitoban families and communities. "This project will help families to stretch their food budgets, while also increasing food security and

resiliency in Manitoba," said
Pedersen. "Learning about food
and how to prepare it is something
families can do together, and
these resources will help give
them the information and
confidence to make it a part of
their daily lives. We are pleased to
support an initiative that will
encourage healthier diets and
contribute to the overall health of
our communities, building on the
good work that is already
happening in our province."

Funding will be provided to the MAHE through the Canadian Agricultural Partnership to develop and promote printable electronic resources on food literacy and safe preparation of affordable and available food, with an emphasis on Manitobaproduced ingredients. MAHE will collaborate with communitybased non-profits working with vulnerable populations, experts in public health and food safety, and the supply chain to ensure their work complements other existing resources and is accessible to

Manitobans.

"With the mission to improve the quality of life for individuals, families and communities, MAHE has the professional expertise and connections to fulfil this project's mandate for the benefit of Manitobans," said Sheila Stark-Perreault, MAHE president.

The five-year, \$3-billion Canadian Agricultural Partnership includes \$2 billion for cost-shared strategic initiatives delivered by the provinces and territories and \$1 billion for federal programs and servicesPedersen noted the Manitoba government has also recently launched the Home Nutrition and Learning Program, which focuses on family-friendly recipes and educational activities. It includes a \$2.5-million pilot program to help connect schoolaged children and their families with nutritious foods to make together



Increase in Employment Shows Positive Growth, Shows Manitoba Leading the Country in Student Employment: Fielding

The latest Labour Force Survey from Statistics Canada shows Manitoba leads the country in student employment and has recorded an increase of 28,900 in overall employment from May to June, Finance Minister Scott Fielding announced today.

"Thanks to the efforts of all Manitobans and based on advice from our public health officials, we continued to move forward in our phased-in approach to restarting our economy and returning Manitobans to work in June," said Fielding. "With increases in May and June, over 40 per cent of Manitobans who lost employment due to COVID-19 are already back at work."

The province moved forward to Phase Two of Restoring Safe Services: Manitoba's Pandemic and Economic Roadmap for Recovery on June 1 and began Phase Three on June 21.

New Manitoba labour force statistics show the province fared better than the national average in key categories. Total June employment in Manitoba increased by 28,900, a 4.9 per cent increase from May, when employment increased by 13,100. The provincial labour

force increased by 23,600 people in June.

Manitoba saw a significant 13.3 per cent increase in part-time jobs, up by 14,200. Full-time employment was up 14,800, a 3.1 per cent increase. Manitoba youth unemployment in particular decreased 3.5 percentage points to 19.3 per cent, the lowest in Canada. This reflects the focus the provincial government has placed on providing opportunities for students to find work. Overall, the provincial unemployment rate edged down to 10.1 per cent, the second lowest in the country and below Canada's rate of 12.3 per cent. The private sector, which includes the self-employed, increased by 25,600, a 5.9 per cent gain from May to June. The national rate for the private sector increased by 6.9 per cent.

The accommodation and food services sector, along with the wholesale and retail trade industry, saw the largest level changes from May to June.

"Manitoba is weathering the economic storm through our slow and safe plan to reopen businesses and restore services. and our job market continues to rebound for a second month," said Fielding. "Our government continues to focus on programs that support employers and employees so even more Manitobans can get back to work."

To date, the Manitoba Gap Protection Program has provided approximately \$44.6 million to more than 7,400 businesses that are ineligible for federal support. The Manitoba Back to Work This Summer Program has provided more than \$3 million in supports so more than 220 private-sector employers could hire and re-hire 600 employees. The Summer Student Job Recovery Program has encouraged more than 1,800 employers to apply for \$20 million in wage subsidies for more than 4,000 student positions.

More than 1,600 people have applied for the Manitoba Job Restart Program to receive a \$2,000 payment if they safely return to work and voluntarily stop collecting the Canada Emergency Response Benefit or the Canada Emergency Student Benefit

Canada Canada decided to keep its borders closed to Europeans beyond June 30. Will you apply reciprocity, bearing in mind that it is on the list of 15 countries to which the EU just reopened its own borders?

In accordance with the recommendations of the European Commission and in close coordination with its European partners, France will move ahead with the gradual and individualized opening of its borders based on the health situations of various third countries.

Norway – Meeting between Jean-Yves Le Drian and his Norwegian counterpart (June 29, 2020) Jean-Yves Le Drian, Minister

for Europe and Foreign Affairs, spoke today by phone with his Norwegian counterpart, Ine Eriksen Soreide. The minister congratulated his counterpart on Norway's election to the UN Security Council as a non-permanent member for 2021 and 2022. He expressed our country's desire to cooperate closely with Norway on issues relating to peace and international security in this context. The ministers discussed the situation in the Sahel, Libya, the Gulf and the Middle East crises regarding which we have converging approaches. Jean-Yves Le Drian and his counterpart also took stock of the international response to the Covid-19 crisis. They discussed

Norway has confirmed it wants to participate. The ministers also decided to continue their discussions on Ukraine and Russia, EU-China relations and the negotiations on the future relationship between the UK and the EU, underscoring the need to preserve our two countries' reciprocal fishing interests.

This meeting follows on from the regular exchanges between French and Quebecois authorities driven by the road maps adopted in 2018 during the most recent rotating meeting between prime ministers and the meeting between Nadine Girault and Minister for Europe and Foreign Affairs Jean-Yves Le Drian in November 2018. Jean-Baptiste Lemoyne notably met with Caroline Proulx, Minister of Tourism, in November 2019. The minister of state and the minister will discuss developments in the health situation in France and Quebec. This meeting will also provide an opportunity to underscore the importance of our cooperation with respect to responding to the challenges posed by the Covid-19 pandemic. It will allow for a discussion regarding ongoing cooperation and the prospects for strengthening our partnerships in the economic, environmental, social and cultural spheres. Indeed, France and Ouebec share unique historical and cultural ties. They have a direct and special relationship focused on shared priorities, starting with the promotion and defense of the French language, notably in international organizations, the promotion of gender equality, the Paris climate agreement and the fostering of youth mobility.

Belarus – Jailing of two presidential candidates (June 23, 2020)

The jailing of two candidates running in Belarus's upcoming presidential election and the arrests of citizens and journalists in recent days on the sidelines of protests supporting those candidates is contrary to the international commitments of Belarus, a member of the Organization for Security and Cooperation in Europe (OSCE). France calls on Belarus to abide by its commitments and to guarantee the freedom of expression and right to demonstrate.

#### WORLD ATHLETICS LAUNCHES 'ROAD TO TOKYO' QUALIFICATION TRACKING TOOL

World Athletics has launched Road to Tokyo ' an online tool to help athletes, media and fans track the qualification process for next year's Olympic Games. Searchable by discipline, country and qualification status, the tool will provide a real time view of each event over the course of the Tokyo 2020 qualification period which ends on 29 June 2021. As announced last month, the Tokyo 2020 qualification system already in force was adapted to fit the new dates of the Games, which were postponed in March. The Games will now be held from 23 July to 8 August, 2021. The qualification principles remain unchanged with athletes able to qualify through entry standards and then the World Athletics World Rankings. Athletes who have already met the entry standard since the start of the qualification period in 2019 remain qualified and will be



eligible for selection by their respective Member Federations and National Olympic Committees, together with the other athletes who will qualify within the extended qualification period.

Due to the uneven training and

competition opportunities around the world during the coronavirus pandemic, World Athletics announced on 7 April that the qualification period (for all events) was suspended from 6 April to 30 November 2020.

education system that will help break down barriers for Black, Indigenous and racialized students and provide all students with an equal opportunity to succeed. As part of this action, the province will move forward with ending Grade 9 streaming into applied and academic courses, proposing to eliminate discretionary suspensions for students, strengthening sanctions for teachers who engage in behaviour of a racist nature, and providing teachers with additional antiracism and anti-discrimination training.

Details were provided today by Premier Doug Ford, Christine Elliott, Deputy Premier and Minister of Health, Stephen Lecce, Minister of Education, and Jamil Jivani, Ontario's Advocate for Community Opportunities.
"To help our young people reach their full potential, we have to start earlier to create equal opportunity for them, whether that's reforming suspensions for primary grades or ending the practice of streaming for Grade 9 students," said Premier Ford.
"Above all, our government will not tolerate racism, anti-Semitism, homophobia, Islamophobia or hate in any form

in our schools. Through these initiatives to promote equality in education, we will ensure students from all walks of life are set up for lifelong success. Through Bill 197, COVID-19 Economic Recovery Act, 2020, the government is proposing to eliminate discretionary suspensions for students from kindergarten up to Grade 3 beginning September 2020. Serious offences will still be subject to mandatory suspensions. The latest suspension data from 2018-19 shows that over 65,000 elementary and secondary students in Ontario were suspended during that school year. Starting in September 2021, the government will begin the process of ending Grade 9 streaming into applied and

academic courses. Currently, students enrolled in applied-level courses have multiple negative outcomes and limited opportunities for post-secondary advancement."Every student irrespective of the colour of their skin, faith, heritage, and orientation — deserves every opportunity to succeed in the classroom," said Minister Lecce. "The transformational change we are driving forward will embolden a generation of students and unleash their full potential, absent the systemic barriers that hold them back. To racialized students in Ontario: we see you. and we value you. We will stand with all students on this journey

advance respect, dignity, and opportunity."
As part of its plan to end early streaming, the government will introduce a new foundational

Grade 9 math course for September 2021 and will work with school boards as they transition students into a destreamed Grade 9 math program. The de-streaming of the Grade 9 math curriculum is the first step towards further de-streaming in other curriculum areas, which will better support all students in having every opportunity to pursue the pathway of their choice after their K-12 education. "We must recognize that today's changes are the result of our government and community members working together," said Jamil Jivani, Ontario's Advocate for Community Opportunities. "In particular, parents in Ontario's Black communities have been a powerful voice for change. providing their unique insights in how suspensions and streaming have disadvantaged black students. Thank you to every parent and community leader who engaged with us in this process." To ensure students feel accepted in a discrimination-free classroom, the government will be strengthening sanctions for teachers who engage in behaviour of a racist nature. Over the last 23 years, the Ontario College of Teachers reports that there have been 32 instances of teacher discipline for racist or homophobic behavior or remarks. The Ministry of Education has also proposed additional anti-racism and anti-discrimination training before the end of the calendar year. The government is currently consulting with teachers' federations, education workers' unions, and trustees' associations on the implementation of this critical initiative.

#### Ontario Expanding Access to the Modern Digital Economy

Application intake for broadband and cellular program opens todayThe Ontario government is expanding access to reliable broadband and cellular service in underserved and unserved parts of the province. The application intake for the \$150 million Improving Connectivity for Ontario program (ICON) opens today. This funding will help drive economic investment and job creation across the province. while allowing more people to work from home more efficiently, engage in online learning, and connect with family and friends."The outbreak of COVID-19 reinforced the need to improve access to reliable broadband and cellular service as more people work and learn from home in order to practice physical distancing," said Laurie Scott, Minister of Infrastructure. "By making these investments we will help to ensure every region in the province can participate in the modern digital economy, and contribute to Ontario's economic recovery." Any areas across

Ontario that do not meet the national standards for broadband speeds would be eligible for provincial funding. Up to 12 per cent of households in the province - mostly in rural, remote or northern areas - don't have adequate broadband service, according to the Canadian Radio-television and Telecommunications Commission. Telecommunication service providers, municipalities. Indigenous communities and nonprofits are invited to submit innovative proposals and lend their investment, expertise and experience to improve connectivity in communities across Ontario. The preliminary application deadline for the first intake of the ICON program is August 21, 2020The province's investment of \$150 million announced today is part of the \$315 million Up to speed ontario's Broadband and cellular Action Plan. This action plan has the potential to leverage up to \$1 billion in partner funding for broadband infrastructure investments.
